This horse is currently located at Foothills Ranch in Roseisle Manitoba, Canada. A current negative Coggins test will accompany each horse, as well as a health certificate and all necessary broker / border documents at no additional cost that are necessary to cross the border into the U.S. if required.

A deposit of \$2000 must be paid **within 3 days of requesting to reserve a foal / horse. A second payment of \$2000 is due on or before **July 15th**. All payments including deposits are Non-Refundable. Balance/Full payment must be received before **September 1st** of the current year. Applicable hauling fees must be received on or prior to **September 1st** as well. Payments should be made out to " Miles and Suzanne Snider ".**

Deposits and additional payments can be made by PayPal, certified checks, bank drafts, E-Transfer, direct deposit, bank wire or any Financial Institution issued International money orders. We also accept Visa and Master Card directly.

No personal checks or postal money orders will be accepted.

Horses will only leave Foothills Ranch if we feel they are 100% sound and healthy. In the event a foal / horse becomes injured or ill during the summer prior to being transported to its new owner, the foal / horse will not travel and a full refund including the transportation fee's will be refunded to the buyer. A veterinarian pre-purchase exam is also available to each buyer at the buyers expense, if requested. We only advertise horses that we feel will represent our breeding program well and are confident in the horses we offer. If any horse fails to pass a pre-purchase exam, we will issue the buyer a full refund including the fees associated with a basic pre-purchase exam.

We personally transport the weanlings / horses or use the best haulers available that have earned our respect and trust. We ensure that they take excellent care of the horses while in transport. We anticipate safe horse transport, however due to the hazards of road travel, possibility of shipping fever etc., the transporter, and seller, can not be held responsible. Insurance is highly recommended for buyers.

Both parties agree upon the following terms: Buyer agrees that from the time their horse leaves Foothills Ranch all expenses incurred - including but not limited to - board (if applicable), veterinary care, farrier, etc. is the responsibility

of the buyer. The horse solely belongs to the buyer from the time it leaves Foothills Ranch on route to it's new owner. All it's expenses are its new owners responsibility. An individual insurance policy for each horse is recommended to cover liability, medical and life. Purchase of horse insurance is the sole responsibility of the buyer. If you are interested in insurance and would like recommendations, please contact us.

If foals are reserved prior to July 1st of their birth year, you have the option to select their AQHA registered name. If you would like to name your foal, please include three name choices to be submitted to AQHA for registration within **3 days** of reserving a foal. Name choices must not exceed 20 characters and spaces. Do not use punctuation marks. Foals purchased after July 1st will already be named, however name changes are available through AQHA.
